- 6. All stock must be delivered in a clean and hygienic manner. Stock must be pocket crutched, free of detectable disease, with skin length no greater than 3 inches. Thomas Foods holds the right, at its discretion, to reject or downgrade livestock supplied by vendors who do not comply. Rejection of stock will result in livestock being returned to property of origin at the expense of the vendor.
